Higher Education Constitutions Debate League, in Arabic Language 2013

Kuwait International Law School participated in the Higher Education Constitutions Debate League that is held for the first time in Kuwait between all public and private higher education institutions, including Kuwait University, American University of Kuwait (AUK), Open Arab University, and The Public Authority for Applied Education and Training.

Higher Education Constitutions Debate League aims at educating the youth and provide them with rich and variable amount of knowledge that enriches their mental capabilities and increases their knowledge.

Students' debate is a competition between two teams in a session dominated by dialogue over a particular issue. Each team tries to persuade the jury by their own opinion and stances by the means of justifications and freedom of speech as well as intuition.

KILAW seized the opportunity and took part in this competition that refines students' talents in expressing themselves, and their opinion by using effective and persuasive techniques, such as rhetoric, oratory, and body language.

After some rounds conducted in Kuwait University, KILAW students possessed prominent positions. In the first round, student Fajr Al-Kandari from the female team defeated the female team of the American University of Kuwait. Student Youssif Al-Sinafi from the male team defeated the male team of The Public Authority for Applied Education and Training. In the second round, however, student Khalida Al-Nahaam defeated Kuwait University team; and student Ali Al-Iryan defeated the female team of the American University. In the third round, student Ali Al-Iryan defeated the female team of the Arab Open University. Therefore, Ali was awarded the best speaker in the competition.
