



## **KILAW SUMMER JOINT PROGRAMME IN LONDON** **WITH MANCHESTER UNIVERSITY & ESSEX UNIVERSITY**

### **Where is the study location in London ?**

At the **University of London, Institute of Advanced Legal Studies**: 17 Russell Square, London WC1B 5DR, UK.

### **Who is eligible to register ?**

The course is optional for students enrolled at Kuwait International Law School, students from associated universities, and anyone who deems this course necessary, provided they meet the enrolment conditions and requirements.

### **Why London ?**

KILAW aims to provide its students and others with the opportunity to experience studying abroad by completing part of their graduation requirements at a prestigious university. This experience is enriched by the exchange of expertise and academic services offered by the associated university, encouraging students exchange programmes and faculty exchange. Additionally, it aims to hone personal skills, foster independence, and strengthen English language proficiency.

## **What courses are available in KILAW Summer Programme in London?**

Three courses, with one section per course, will be offered: (1) Introduction to European Union Law, (2) E-commerce Law, and (3) Islamic Financial Transactions System. These courses will be taught in English by faculty members from KILAW and from the associated universities.

## **What are tuition fees for the Summer Programme in London?**

KILAW Summer Course fees will apply:

The tuition fee per course is KWD 585, in addition to a registration fee of KWD 25 for non-registered students (If cancellation occurs after 20th May 2024, 50% of the fees will be refunded. If cancellation occurs after 1st June 2024, tuition fees are non-refundable). Students interested in this programme must arrange all related matters, such as travel bookings, accommodation, or a UK entry visa, and are fully responsible for these expenses.

## **How do I book accommodation in London?**

Arranging accommodation in the UK and transportation to and from the university is the responsibility of the student enrolled in this summer programme without any intervention or obligation on the part of KILAW to arrange such matters.

## **What are the selection criteria for registration?**

Registration priority will be given to those who apply first, Provided that the conditions and criteria for prioritizing students with the highest GPA and language proficiency are applied.

## **What are the registration requirements for non-enrolled students?**

A law student or a field qualified for knowledge, proficiency in English, passing the personal interview (if required), and paying the tuition fees. A course completion certificate will be issued for the non-registered student who successfully passes the exams of the course and adheres to the requirements of the coursework, including participation, attendance, and assignments. It is the responsibility of the student to ensure the course equivalence with their university.

## **Is attendance mandatory for the Summer Programme in London?**

Attendance is compulsory for those enrolled in the programme. This programme adheres to KILAW's standard regulations for attendance and grading.
