Course Description

102E English will reinforce and expand the reading and writing activities taught in English 101E. and English 101E (academic writing demonstrating knowledge, understanding, analysis and application of ideas) with exceptional emphasis on law and law-related topics, such as family law, child custody law and the judiciary system. In addition to what has already been learned in other writing courses, English 102E focuses on a cause-and-effect essay writing. Students will also practice listening to legal texts and answering facts and details questions. At the heart of the course is academic inquiry, posing critical questions in order to construe and synthesize existing knowledge, to construct a new connection and to develop the skills they acquired from what has been learnt in previous English language courses. In keeping with the practice of maintaining a sustained reading of a single text (as is common for 101E. and 101E English courses), students in 102E will also learn how to incorporate multiple sources and secondary materials into fully developed written essays. After the completion of the course, students will be able to understand and answer questions related to listening comprehension. The main focus of the questions will be identifying the correct details from a listening text as well as differentiating True and False information. In addition, English 102E aims at enhancing learners' skill of performing single and group academic presentations through learning how to extract the main ideas of different resources and integrating them in one unified sequenced presentation that can be used as basis for academic debates and discussions.

Course Goal

The main goal of this Intermediate legal English course is to equip students with essential English communication skills in legal contexts, legal terminology, critical thinking and professional practices that will enable their success in academic and legal professional journeys.

Course Objectives

By the end of the semester, students will:

1. Improve ability to analyze and extract information and details from legal texts.
2. Expand legal English vocabulary and improve ability to apply vocabulary based on the given context.
3. Enhance grammatical skills by implementing the rules of different grammar components.
4. Develop speaking skills through presentations on legal topics.
5. Reinforce skills in writing cause and effect essay on legal topics.
6. Enhance listening comprehension skills in legal contexts.
